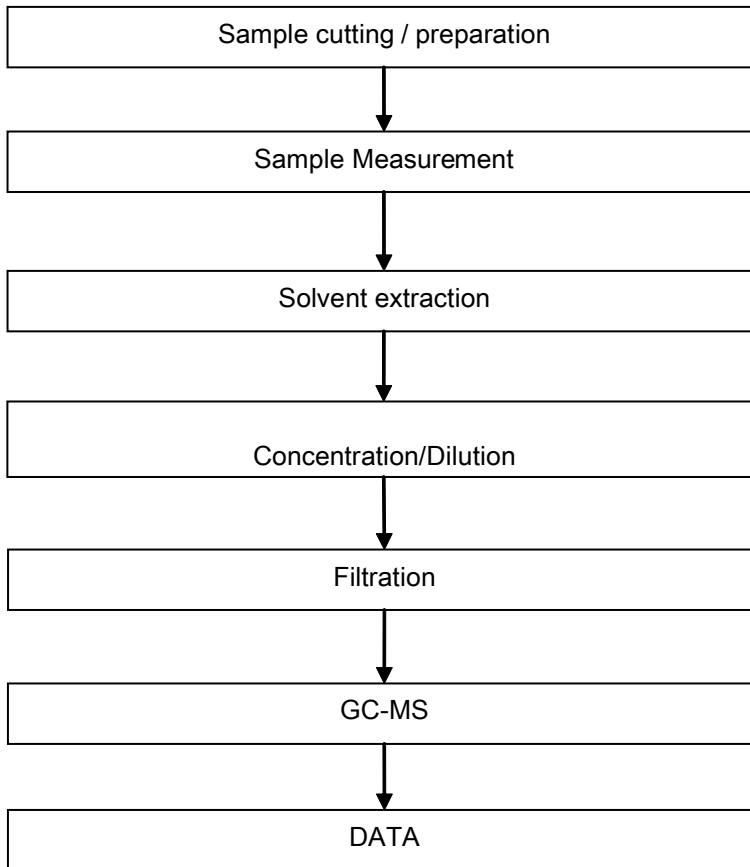

Phthalates Testing Flow Chart

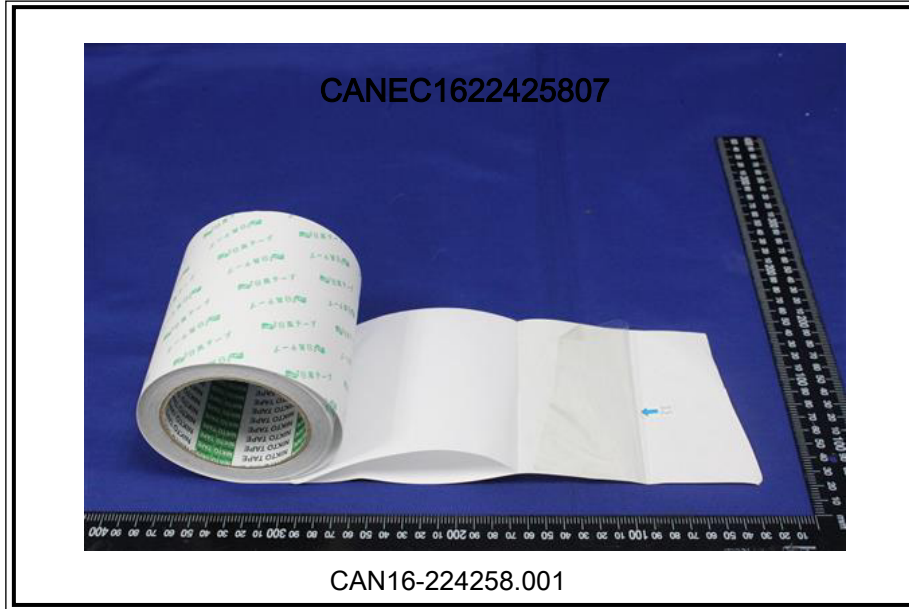
